# OVERVIEW

## PRESIDENTS REPORT

In my final year of the two-year term of BASHH presidency we have accelerated the pace of change needed within the organisation. As usual, it has been an incredible year with so much to be positive about, meeting, working, and collaborating with the best people within BASHH, Genitourinary Medicine (GUM) and across the sexual health and HIV sector. That said, there are still huge challenges to face together to overcome the barriers to delivering and receiving the best care possible for people needing sexual health and HIV care.

In the last year we commissioned M+F Health to manage our social digital media strategy, developing, managing, and delivering activity across all our social media channels. We have regular updates on social media activity, including involvement from BASHH media group on developing and mediating content. Over the next 2 years we aim for all special interest groups to have engaged with the social digital media team, highlighting the exceptional work they deliver on behalf of members, the team, and the service users.

We have commissioned M+F Health to deliver a large scale and multi-year GUM trainee recruitment campaign: #LoveGUM. The M+F Health team are working with the Specialty Advisory Committee (SAC) chairs, Dr Sarah Schoeman and Dr Andy Williams in conjunction with Dr Katia Prime, Dr Nadia Ahmed and the Student and Trainee Association of Sexual Health and HIV (STASHH) team. Plans are being developed and will be shared with the membership once we have next steps.

On the subject of workforce, BASHH Board are acutely aware of the pressures within sexual health services affecting all staff, doctors, nurses, health advisers, support workers, management and administration staff. The impact these pressures have on the membership and therefore on our service users is deeply worrying. I outline here some of the approaches I have taken, supported by board, this list is not exhaustive and is by no means all that we will continue to try to deliver.

I am co-chair of the HIV Action Plan: Implementation Workforce Task and Finish group. I chair this group with Professor Jonathan Corne, the GUM Associate Dean. We are developing recommendations to put into the Action Plan. This addresses all the workforce needs to support delivery of the Action Plan and ultimately help us meet the ambitious target of meeting zero new transmissions of HIV by 2030.

These recommendations work across all professions that support delivery of HIV care, PrEP and prevention delivery in community, across the NHS, sexual health services and HIV services. We are working very closely with the Faculty of Sexual and Reproductive Health (FSRH) to ensure we do not have gaps where service users, in particular women, may present for care. Dr Janet Barter, FSRH president is working very closely with me to ensure we stay focused on making sure both GUM and Community Sexual and Reproductive (CSRH) posts are part of the solutions. I am incredibly grateful for the positive and co-operative relationship which prioritises all the needs of our service users.

FSRH and GUM are beginning to develop recommendations to support the drive coming for the new NHS Workforce plan which we hope will draw some much-needed attention to recruitment issues in both GUM and CSRH.

We are working with English HIV and SH commissioners to look at driving some of this work and focusing on ensuring standards for workforce are at the heart of any investment within commissioning. BASHH should provide leadership for the GUM/STI workforce and work with professional bodies to ensure high standards are maintained.

Alongside the work on workforce within the HIV Action Plan Implementation group, I co-chair the Low Prevalence Task and Finish group. Both of these groups feed into the HIV Action Plan led by Professor Kevin Fenton. We continue to work with the multi-organisation multi-professional organisations as part of this work which is vital to meet the 2030 target.

We have striven to improve the delivery for members, both by improved functions of our secretariat and providing support for social media and communications. We have also agreed to support the Clinical Effectiveness Group and Clinical Standards Unit. We must deliver guidelines and standards, these are at the heart of what BASHH stand for. We have commissioned a medical writing company, Scinopsis to support the Chairs, Professor Margaret Kingston and Dr Dawn Wilkinson to deliver the guidelines and standards that the sector as whole look to BASHH to deliver in a timely way. We will turbo charge the delivery of this work over the next two years.

## PRESIDENTS REPORT *continued*

The BASHH 2023 annual conference in Llandudno was an incredible conference spent learning, networking and connecting with colleagues. Dr Chris Ward, conference chair delivered a fantastic event and is pushing forward with the conference team to make conference more inclusive than ever. BASHH approved for the first year ever to support a multi-professional delegation to attend the International Society for Sexually Transmitted Diseases Research (ISSTD) international conference on the study and research in STIs and provide a feedback event to the wider membership. This was delivered in September 2023 and is available as an online webinar on the website.

We need to continue to evolve as a professional organisation and are continuing to look at improving our structure, beginning to seriously consider new structures including recommending a chief executive model and providing some paid time for vital roles within the organisation. We can't go on expecting hard working colleagues with other full-time jobs to deliver the best they can when they have no time to deliver for BASHH. Critically this will not drive diversity or open opportunity for a diverse representation at board level. Recommendations on how we can do this will be with members very soon with the opportunity to vote on a new model of senior structure and further examine how we can be cost effective, generate income to deliver our vital work and work more effectively and efficiently.

In addition, strengthening collaboration has been a key aspect of the last two years. I have worked very closely with Terrence Higgins trust (THT), Richard Angel (chief executive of THT) and supported BASHH to move Sexual health and HIV onto the political agenda. Working with Deborah Gold (Chair of National Aids Trust), Professor Jim McManus (Association of Directors of Public Health ADPH president), Dr Janet Barter (FSRH President), Professor Kevin Fenton (Faculty of Public Health FPH and Public Health Director of London) and others has been incredibly productive and beneficial to BASHH. Raising the issues we have as a specialty and developing plans to address them will not happen if we work in isolation. We continue to value and work hard with colleagues to move the agenda forward around training, recruitment, quality, access and innovation.

Professor Susan Hopkins, Chief Medical Officer (CMO) of United Kingdom Health Security Agency (UKHSA) has been incredibly supportive in developing an STI roundtable event with plans to address the increasing rates of STIs, and a syphilis summit, which I co-chaired, beginning to develop action plans to tackle the worrying rates of STIs with a focus on syphilis which requires cross organisational and cross sector work. This focused work will produce action plans over the next 6 months.

We work with other organisations to help drive improvements in sexual health services, demand increased funding and improve cross sector working. This year I have attended regular meetings with the Department of Health (DoH), Office for Health Improvement and Disparities (OHID), UKHSA, ADPH, English HIV and Sexual Health commissioners, Local Government Association, Royal College of Physicians, Royal College of Obstetrics and Gynaecology, FSRH, the World Health Organisation (WHO), HIV Clinical Reference Group (CRG), M+F Health our communications and public affairs agency, and NHS England (NHSE). I have met with leaders in the devolved nations and attend the Clinical Governance Committee (CGC) meetings to ensure I am keeping in touch with clinicians on the ground. I meet with many of the special interest groups within BASHH who describe the ongoing opportunities and challenges which BASHH can support. In addition, I have met with many of the BASHH membership to hear the incredible work being developed and delivered. Wherever we can, we will share this work and support people to seek out opportunities to propagate the examples of best practice.

The upgrade of the BASHH website, is a huge piece of work being led by Dr David Phillips, General secretary with Dr Cara Saxon, Ass. General secretary, Kaveh Manavi, Vice President in conjunction with EBS, the secretariat team. This will enable additional much needed functionality and support members to have the best access to the work we deliver collectively.

Lastly, I would like to acknowledge the work of all BASHH board members and in particular the hugely committed and hardworking officer team, Kaveh Manavi, David Phillips, Chris Ward, Sophie Forsyth, Cara Saxon, Rona MacDonald and Matthew Phillips.

In my final few months as president, I hope to continue to push forward essential changes along with the board and BASHH membership. I know the members will play their part and keep board informed as to how we can best drive your organisation.

## TREASURER'S REPORT

### Financial Review

This year has seen a change in direction in relation to expenditure which affects BASHH's financial position both in year and for the forthcoming years. Notably, there has been a shift in focus in delivering activities across BASHH which include website reconstruction, sponsoring delegations to international conferences to bring back learning for the BASHH membership, commissioning events experts to manage the flagship conference and perhaps most significantly the appointment of a fixed term Chief Executive Officer. All of these activities serve to further the objectives, and all have cost significant amounts of money and will continue to do so for the next two years. This is likely to require a mobilisation of reserves.

The expenditure this year has been somewhat counterbalanced by a recovering investment portfolio and increasing conference incomes. Overall, BASHH will have a deficit in 2023. These figures are unaudited

Income £755,975 (2022 £740,731), Expenditure £771,044 (2022 £634,166).

Net gains/losses-£15,069

Surplus/Loss (including investment change) -£14,624

In relation to financial risk, funding is derived through a membership model and it has been decided that all membership categories will increase by 3% in 2024. Whilst this will represent only a small uplift in income, it is a preventative measure to protect against a very steep uplift in the forthcoming years to account for inflation and increased activity.

Structural work has occurred which means that BASHH now banks across three differing companies, the underlying assumption being that each bank insures the first £85,000 of investment and so once the three accounts have each achieved £85,000 sums, BASHH will then have a minimum of £255,000 at its disposal should there be significant shifts in the economy.

The Education Committee is responsible for facilitating the delivery of the BASHH's vision, values and service priorities through education, training and development. The Educational committee (EC) and Special Interest Groups (SIGs) develop and maintain educational programmes providing high levels of specialist training and skill, whilst embracing a wider, more integrated sexual health remit across a wide geographical area and range of healthcare settings.

The COVID pandemic brought new challenges in delivering education and training and our members have continued to adapt to teaching online ensuring that events are interactive and inclusive. We have held more in person events again this year (albeit affected by rail strikes in some cases!) as well as hybrid events while recognising the benefits in terms of accessibility of virtual meetings.

### The Special interest groups (SIGs)

The SIGs lead on the development of educational materials and meetings within their specialist areas. They develop and deliver educational programmes and courses. They also contribute to education and training by generating publications and research, developing guidelines and recommendations in collaboration with other BASHH groups and external organisations, and reviewing and responding to documents on behalf of BASHH. Individual reports detailing specific contributions are available within the BASHH Annual Review.

This year the SIGs provided several well-established courses online, hybrid and in person such as Genital dermatology, SAS Doctors conference, HIV masterclasses and the Diplomas in GUM and HIV revision courses. The Gender and Sexual Minorities SIG has been re-established in the past year and has already led a symposium at the spring conference and has great plans for future projects and educational events.

Dr Ellie Crook has continued to lead the Student and Trainee Association for Sexual Health and HIV to great achievement and has handed over the reigns Dr Ellie Cochrane as Ellie Crook is now a consultant. STASHH was formed to improve recruitment to Sexual Health & HIV medicine by facilitating clinical & academic opportunities for medical students & Pre-specialty Trainees. They have membership from the majority of medical schools and deaneries and put on monthly webinars and also contributed to the Spring conference.

### BASHH scientific meetings

The EC has the responsibility of providing regular Scientific meetings, which are free to BASHH Members. SIGs take it in turn to organise these meetings and they often take a two-part structure, organised by two individual SIGs. They have mostly been held virtually over the past year with one hybrid meeting in March with excellent attendance figures and good audience participation via chat.

October 2022 saw the prison SIG lead the virtual BSM for the first time in a few years, presenting work done by the BASHH educational fellows and with moving and inspiring testimony from prison SIG members with lived experience of prison healthcare. The HPV SIG also presented new BASHH wart guidelines.

The January meeting was led by the RMC SIG for the first time as well the HSV SIG. March saw our second hybrid BSM with the newly renamed Sexual Function and Wellbeing SIG and Adolescent SIG informing and entertaining audiences both at the Royal Society of Medicine and many more around the UK and beyond on Zoom. It was an honour and a delight to have Prof Rak Nandwani in person to receive his Honorary Life Fellowship and inspire us with his tales of a life in GUM. Podcasts/webcasts of the lectures are available on the BASHH website for members to access in their own time if they were unable to attend the meeting.

### Scholarships, Fellowships and Travel awards

The Education Committee has secured BASHH funding for a remunerated fellowship for the coming year to ensure equity of access for all BASHH members and we look forward to appointing this fellow in the near future.

The Undergraduate Essay prize winners in 2023 were Rebecca Coltart (University of Glasgow) for her essay 'How many Sandyford HIV PrEP patients will require TAF-based PrEP according to draft BASHH/BHIVA guidelines?' and Aishah Hagan-Bezgin (University of Liverpool) for her entry 'Preterm Birth in Pregnant Women Living with HIV: The Role of Neutrophils'.

We look forward to ever more informative and inspiring educational events in 2023-4 be they virtual, in person or hybrid.

### Objectives

- To recommend strategies for IT implementation, data collection and reporting for the spectrum of Sexual Health services (ranging from non-integrated services to fully integrated services).
- To liaise between DHSC, HSCIC, UKHSA and other agencies regarding information issues to achieve best outcomes for both patients, the public and public health.
- To advise on the type, quality and format of information to be collected from Sexual Health services for the purposes of national audit, public health monitoring and monitoring of service performance.
- To respond to relevant consultations affecting service provision, data collection and information governance in Sexual Health.
- To receive and respond to queries and concerns from members relating to IT and information governance, including data protection and confidentiality rules.
- To anticipate issues relating to IT and information governance from new legislation, commissioning or other changes that affect Sexual Health.
- To disseminate important information to BASHH/FSRH members via organisational websites/newsletters.

### Significant activities / Outputs 2022-2023

- The Group met on 3 occasions during 2022-23
- The Group continued its work, responding to the Mpox virus outbreak by liaison with services and UKHSA to develop and rapidly deploy intuitive and practical Mpox activity, diagnostic and vaccination codes – expected to pave the way for accurate capture of epidemiology data, vaccine delivery and service provision aligned with tariff algorithms.
- The Group continued to work with DHSC and NHS Digital to produce the consensus statement for confidentiality in Sexual Health Services (following the lapse of the NHS STI regulations).
- The Group responded to numerous questions posed by BASHH members regarding data management, information governance and statutory reporting for sexual health services.
- The Group advised UKHSA on matters arising including GUMCAD and HARS
- The Sexual Health – EPR (Electronic Patient Record) working group finalised and launched the standardised specification for EPR.
- The group, and EPR working group, supported services impacted by the sudden closure of Mill Systems
- The EPR group concluded a national survey evaluating sexual healthcare practitioners' experience of EPR systems, the result of which were presented at BASHH 2023 winning best Poster prize.

### Future plans

- To continue to work closely with members of the FSRH, National Institute for Health Protection, UKHSA, DHSC, NHS Digital, software providers and others to ensure that we meet our objectives.
- To ensure the objectives and benefits of this Group incorporate relevant issues for all devolved nations of the UK.
- To be both pro-active and responsive to upcoming matters that affect data handling and Information Governance to produce and disseminate best practice advice to BASHH & FSRH members.
- To continue to review standard EPR specification and engage with all stakeholders to promote and iteratively develop it.
- To update and repeat the national EPR survey to draw on experiences and ideas across integrated sexual health services to drive change in the market and iterate the specification.

### Objectives

- To produce the BASHH guidelines for the management of sexually transmitted infections & related conditions

### Significant activities

- Ongoing review of the current BASHH guidelines and patient information leaflets, production of updates and of new guidelines. This remains a key output for BASHH and sets acceptable professional standards of care, facilitates good patient care and supports healthcare professionals to make appropriate and evidence based decisions choices when managing their patients.
- Liaison with key internal and external stakeholders. This year the chair has participated in additional meetings with UKHSA concerning doxycycline pre-exposure prophylaxis, STI screening frequency and a summit convened by BASHH and UKHSA with many external stakeholders concerning the increase in syphilis cases.
- The CEG continues to meet three times per year with one a blended face to face and two virtual meetings.

- The production of the guidelines is undertaken largely by BASHH members and their colleagues in the interests of the specialty and is unremunerated. We have been working with a professional researcher to undertake literature reviews in recent years which has supported their work. This year we obtained support from the BASHH board to employ a medical writing company to work with the guideline writing teams, Schinopsis. They have refreshed the guideline template and started working with the guideline groups which should make the guideline outputs more uniform and timely, and relieve workload from the authors.

- Maintenance of the BASHH guideline portfolio including co-produced guidelines with key external stakeholders including BHIVA and FSRH
- Ongoing liaison with stakeholders
- Ongoing input into the BASHH annual conference; guidelines session
- Guidelines updated since last report:
  - 2018 BASHH guidelines for the management of Mycoplasma genitalium
- Guidelines completed since last report:
  - 2023 BASHH guidelines for the management of sexually transmitted enteric infections

- To promote Genitourinary Medicine as a career option for medical students and pre-specialty doctors as part of the Students and Trainees Association of Sexual Health and HIV (STASHH) steering committee.
- To provide quality educational opportunities for DiTs and facilitate communication about professional and training events.
- To arrange networking and socialising events for DiTs.
- To ensure DiTs representation on BASHH Committees.
- To sit on the JRCPTB Genito-urinary Medicine Specialist Advisory Committee (GUMSAC) to represent trainees.

### Significant activities

- Continued national teaching day for all GUM trainees in a concerted effort to improve access to quality teaching from nationwide speakers.
- Supporting development of a future recruitment plan for Sexual Health and HIV medicine through support of careers events and being part of the steering committee of Students and Trainees Association of Sexual Health and HIV (STASHH).
- Continued support of DiTs with the new GUM/General Internal Medicine curriculum and facilitating bidirectional feedback between DiTs and GUMSAC.
- Sitting on the conference committee to contribute to organising the annual BASHH conference.
- Increasing collaboration with the BHIVA DiT representative and HIV Trainees Association (HIVTA).

### Performance/Outputs in the year 2023-2024

- Teaching days were held online in September 2022 and May 2023. A new teaching timetable for 2023-2024 has been arranged with dates in October 2023, February 2024 and May 2024.
- A survey was held to establish an appetite amongst DiTs to reinstate an annual face-to-face DiT pre-conference day in June 2023. Feedback on the virtual teaching days throughout the year has been very positive with DiTs repeatedly giving a preference for online events to save on travel cost/time. However there was still an appetite for a face-to-face event to facilitate networking and socialising for DiTs who attend the conference. Therefore, a very successful face-to-face socialising and networking event was held prior to the BASHH conference in June 2023 for all trainees including pre-specialty doctors and medical students.
- Followers on the @BASHH\_trainees Twitter account continue to increase with sustained promotion of recruitment events and relevant courses.

- STASHH continuing to grow with new committee members and local ambassadors for almost all UK medical schools and deaneries. A consultant representative from the GUMSAC has also been appointed to attend STASHH board meetings to facilitate communication between STASHH and UK-wide TPDs which has been a very positive change.
- A very successful year for the 4 pillars of STASHH:
  - Education – season 2 of the STASHH podcast has been recorded and will be aired throughout the year. Monthly education webinars have resumed.
  - Mentoring – 66 mentees and 32 mentors signed up to this program. Later stage pre-specialty trainees (i.e. IMTs) are being prioritised for the mentorship program.
  - Recruitment – largely led by local ambassadors who arrange local meet-ups, disseminate STASHH updates/meetings/podcasts/educational events.
  - Project – continues to support students and pre-specialty doctors with QIP and to disseminate information about opportunities.
- Following ARCPs in May/June 2023, DiTs provided lots of helpful feedback about their experiences. This was discussed with GUMSAC and a document was created with detailed information from the chairs addressing common problems/concerns experienced by trainees at the first ever GUM /General Internal Medicine ARCPs. This document was disseminated to trainees who found it very helpful to clarify common issues e.g. expected number of assessments in General Internal Medicine.
- A 'Leaflet on Higher Specialty Training in GU Medicine' for the new BASHH website has been developed by DiT representatives to BASHH and BHIVA which includes information about GUM training with stories/quotations from current trainees.
- DiTs have contributed to the development of a survey by JRCPTB to explore trainees experience of the change in curriculum which should hopefully be disseminated soon
- A WhatsApp group of all dual-accrediting trainees nationally has been created and is very active to discuss ideas and challenges, as well as to provide peer-support, for those dual accrediting in GUM/General Internal Medicine.
- BASHH DiT representative continued to be part of the BASHH conference committee in June 2023 with the expectation that this is will be on ongoing role for future representatives.

### Future plans

- Ongoing virtual teaching days dispersed throughout the year
- Annual face-to-face pre-conference DiT socialising/networking event
- Continue close involvement with STASHH with the DiT representative expected to contribute to meetings and partake in workshops and projects where appropriate

## MEDIA GROUP

### Public, Media and Website Activities

BASHH has continued to priorities maintaining and delivering an effective and expert-driven press office in the past 12 months, handling a range of sexual health-related media enquiries from leading national journalists and producers. Topics handled have included annually published STI data by the UKHSA- and the increasing rates of infection captured within them- Mpxv vaccination, workforce reform and sexual health prevention.

Regular updates have been published on the news section of the BASHH website, helping to showcase the release of relevant educational and training resources, as well as to highlight various BASHH statements on policy and service developments. Several news items have been published each month on average, ensuring members are regularly updated and able to access pertinent educational information.

Significant engagement has also been undertaken with key stakeholders across the policy and political landscape, with the aim of continuing to raise awareness of key sexual health service pressures, and securing support for adopting solutions at national and local levels. Relationships have been strengthened with leading health representatives across the major UK political parties ahead of an anticipated 2024/25 General Election, as a result of ongoing engagement and meeting programmes.

Close working has been undertaken with allied sector organisations to develop co-authored engagement letters and calls to action around critical service delivery policy challenges. BASHH has also maintained its ability to respond effectively to relevant consultations, which in the last year has included input into the Parliamentary Women and Equalities Select Committee inquiry on reproductive health. Steps have also been put in place to ensure that BASHH is able to feed into future relevant Select Committee inquiries, including an ongoing Health and Social Care Committee inquiry on prevention.

### Social and Digital Media

Building on the plan put in place in February 2022, BASHH have worked with M+F Health to implement a multi-channel social media strategy. Seeking to professionalise and refine BASHH's social media channels, an audit conducted this year highlighted marked improvement across all channels, from May 2022 to May 2023. These improvements included a notable 11% follower increase on X (formerly Twitter), a 26% increase in Instagram followers, and LinkedIn followers more than doubling over the 12-month period (increasing from 482 followers to 1,032).

Activity has included the development of a series of topical blogs around key wider milestones, including pieces co-authored by Dr Stuart Flannagan, HIV & BBV SIG Chair, and Lorraine Stanley, CEO of SWAD. BASHH's social media channels have increasingly adopted a stronger organisational identity, with the development of bespoke visual assets, and on Instagram, the creation of a BASHH 'Linktree', a link-in-bio solution that can be used on social platforms.

The success of the 2023 BASHH Annual Conference campaign (creative campaign part 1) in June represented a significant milestone, with over 320 social media posts shared across all channels in the month, reaching an impressive 139,000 people on X alone. The conference hashtag, #BASHH2023, was used more than 1,400 times in the month and 470 people were driven to the conference pages on the BASHH website via social media posts. Plans have been developed for the second phase of the creative campaign, comprising social media advertising and a detailed targeting strategy for BASHH's Twitter/X, Facebook, Instagram, and LinkedIn platforms

### Objectives

- The BASHH STI & HIV Course consists of 4 modules that run once a year covering:
  - Module 1: Epidemiology of STIs and Bacterial Infections
  - Module 2: Sexual health and sexuality
  - Module 3: Viral Infections other than HIV
  - Module 4: HIV infections
- It aims to improve in depth knowledge and management of STIs and HIV to current national standards and to aid those sitting the Diploma in GUM and Diploma in HIV exams. It has, however, been mapped to the wider GU SpR curriculum; therefore other clinicians such as SRH trainees and other senior healthcare professionals within the MDT (with their own patient cohorts) are also able to benefit.

### Significant activities

- Feedback. The course has continued to run successfully online with lead clinicians for each day. Evaluation of the feedback and module programmes has continued throughout this reporting year. Feedback has continued to be excellent.
- Online course portal. Transfer of all course material onto an online portal hosted on the BASHH website has been completed, allowing delegates to access all course material including programme and presentations online.
- E-learning. All 4 modules of the course programme have been fully mapped to both the curriculum and the e-lfh modules. Candidates can complete modules prior to attendance.

### Future plans

- Oversight of the course is transitioning from Dr Ngozi Dufty to Dr Laura Waters in 2024 with Dr Sophie Forsyth (EC chair) in the interim.

### Objectives

- Improving knowledge of HPV, its clinical sequelae and advice on vaccination.

### Significant activities

- National campaign detailing recent changes to the national HPV schedule for MSM in GUM/SRH clinics from 2023
- New national guidelines on HPV and warts are due to be published imminently. We extend our gratitude to the hard work of the writing group for their input.
- In conjunction with BASHH, BHIVA, surgeons and other key stakeholders, our bid for anal cancer screening in those living with HIV (aged over 40 years) was successful.
- The National Screening Committee have agreed to look at evidence and feasibility of a new national anal cancer screening program after new evidence showing treating AIN lesions dramatically reduces anal cancer incidence

- The National Screening Committee is awaiting evidence from the US Prevention Task Force to see what next steps would be feasible. The CDC is due to release recommendations which we will use to speed up the process.
- The HPV SIG is also undertaking a UK-wide assessment of current HRA and anal cancer screening services to help the Screening Committee with their recommendations (survey due out in October 2023)
- Arranging a national course for those interested in high resolution anoscopy (due March 2024)
- We are arranging a symposium at the International Papilloma Virus conference in 2024 with clinicians and academics (and possibly patients) to allow dissemination of the most up to date information on HPV vaccination and its impact on anal cancers and warts in GBMSM
- Two new clinicians joined the group – Dr Iain Reeves (Consultant HIV/GUM at Homerton) and Dr Beth McMahon (F3 at Homerton – referred from the trainees group STASH)

### Objectives

The Joint Specialty Committee (JSC) for Genitourinary Medicine (GUM) acts as an advisory body to the Royal College of Physicians (RCP) on matters concerning sexual health and HIV. It meets twice a year and has a membership drawn from both the RCP and BASHH. There is usually representation from the RCP's Patient and Carer Network but recruitment to the two vacant posts was paused due to the COVID-19 pandemic.

### Significant activities

- The Committee has met virtually using an online platform with meetings in November 2022 and June 2023.
- Interim discussions between scheduled meetings have taken place and the chair attends the Joint Medical Specialty Board meetings.

### Performance/Outputs in the year 2022-2023

- The Committee has ensured that the RCP is fully advised about the issues affecting the specialty, including workforce planning and training, and the commissioning and tendering of HIV and sexual health services.
- The Committee has updated the RCP on standards that were relevant to GUM including those produced by NICE, BHIVA, NHS England, BASHH and the FSRH.
- The Committee has responded to a wide range of national consultations.
- A proposal to change the name of the specialty from 'GU Medicine' to 'Sexual Health and HIV Medicine' has been submitted to the RCP.
- A robust review of GUM Consultants per region has been undertaken to assist with future workforce planning.

### Future plans

The Committee will:

- Continue to ensure that issues of importance to the speciality are raised with the RCP.
- Work to ensure training and workforce planning issues are addressed.

## SPECIALIST ADVISORY COMMITTEE

### Significant activities & performance

#### Outputs 2022-23

##### Curriculum

- Newly appointed trainees from August 2022 are now dually training in GUM and Internal Medicine (IM), in addition to some trainees in previous singly accrediting GUM posts who have chosen to transfer to the new curriculum
- All dually accrediting trainees need an educational supervisor (ES) in both GUM and in IM. In some centres it has been challenging to appoint an ES in IM but local Heads of School are committed to supporting this process
- Individual training needs and gap analysis are being discussed and documented at the trainee's next ARCP. Extensions to training are being supported if needed.
- IM ARCPs have started for those on the new curriculum from May 2023 with local arrangements regarding separate IM ARCPs or IM assessor on GUM panels. The latter has worked well for London ARCPs
- External advisers continue to support ARCP panels over MST
- The GUM rough guide, syllabus and a new ARCP decision aid have been developed to support the new GUM/IM curriculum and are available on the JRCPTB website
- A post curriculum implementation questionnaire has been developed and is due to be distributed imminently to all group 1 specialties
- The outgoing co-chair, Dr Prime, has stayed on the SAC as curriculum lead, providing continuity whilst the new dually accredited curriculum embeds.
- The Diplomas of GUM and HIV continue to be critical progression points for the curriculum with the former needing to be achieved before entry into ST7. A working group has been convened to explore whether the Diplomas can be made more cost efficient, with savings passed onto trainees

### Workforce & recruitment

- HEE has been undertaking a workforce review of all training numbers with a view to re-distributing training numbers as they become vacant from inside London to elsewhere. GUM were due to be considered in 2027 but with HEE's integration into NHSE&I this work has been paused.
- We remain very concerned about the high number of vacant training posts in GUM and are working closely with BASHH and other stakeholders to address this. Initiatives that the SAC have been involved in are listed below

### Promotion of the specialty

- Working with BASHH and M&F media team to support National Love GUM campaign to increase awareness of a career in GUM and promote recruitment to the specialty
- Providing TPD support to STASHH to improve profile, opportunities and mentorship for medical students and trainees interested in a career in GUM
- Establishing GUM and HIV education on IMT and FY teaching programmes Nationally
- Supporting BASHH trainee educational fellowships
- Invited to present on a career in GUM at National HEE careers advisers' meeting
- Meeting between BASHH, cSRH, SAC chairs, and lead Deans to discuss recruitment and workforce issues and support needed

### Succession planning

- The out-going co-chairs finished their tenures in July 2023 and handed over to the new GUM SAC co-chairs: Dr Andy Williams, Consultant in GUM/HIV at Barts Health NHS Trust and Dr Sarah Schoeman, Consultant in GUM/HIV at Leeds Teaching Hospitals NHS trust. Dr Katia Prime has stayed on as the GUM SAC curriculum lead.

## WORKFORCE REPORT

To 30th August 2023 33 permanent posts (22 full time) and 7 locums have been advertised, all except 4 for a mix of GUM or integrated sexual health with an HIV component. This compares favourably with 2021, when 31 permanent consultant posts advertised (20 full-time posts). Of note 2 posts have been advertised on a number of occasions and remain vacant. Neither of these include an HIV component and both are with a non-NHS provider.

The current rate of consultant posts being advertised is now beginning to exceed the number of trainees gaining their CCT, although most posts are reported as being filled at present. It is likely that in the short to medium term trainees will have a selection of consultant posts and those perceived to be less desirable will be increasingly difficult to fill.

It remains to see how supply and demand will be matched with the impending change to training with dual accreditation, the impact of the low fill rate of training posts in the last 2 years and the upcoming changes to sexual health commissioning. This challenge has been highlighted to the JRCPTB and HEE and a couple of workshops have taken place.

Over the last 12 months, we have undertaken an in-depth analysis of current consultant situation to see how it matches with the RCP census and to collect data on existing vacancies.



The latest RCP census data has a headcount of 491, 440.7 WTE compared with BASHH 487.6 headcount (including vacancies) and 378.3 WTE (including vacancies). The WTE found by BASHH is significantly less than that in the census data, and seems to reflect the continuing feminisation of the workforce and LTFT working, the BASHH survey identifying colleagues, who although GUM consultants undertaken significant other roles which reduce their contribution to GUM, eg Medical directors, DME etc.

## UEMS IN DERMATOVENEREOLOGY

### Objectives

My aim at UEMS is to maintain good communications and collaboration with colleagues in Europe with regard to training, standards and development of our specialty.

### Significant activities

The 2023 meeting was held in Salzburg and attended by 47 delegates from 24 European countries. Most of the discussions have

related to the challenges of delivering dermatovenereology training where provision varies hugely from country to country and within countries. Michel Janier has resigned as the chair of the STI division and has been replaced by Marko Potoknik (Slovenia). Henri deVries is the new representative of the Netherlands, increasing STI representation. The European board exam remains the major workstream, taken by approximately 100 candidates annually (aimed at the end of residency). The majority of those taking the exam remain non-Europeans.
