# Overview

## President's report

As President of the British Association for Sexual Health and HIV (BASHH) it is a privilege for me to submit our annual review for the year ended July 2018, which details the Association's many activities and achievements in line with its charitable aims, which continue within a responsive organisational framework.

Sexual health, reproductive health and HIV services across the UK continue to face challenges from a myriad of sources. In England, the on-going tendering of services and tight financial constraints continue to pose significant challenges for providers and commissioners alike. Whilst in Northern Ireland, Wales and Scotland, increasing demand with limited investment in services and workforce is also a major concern, with a Welsh Government commissioned *'A Review of Sexual Health Services in Wales'* finding for instance that there has been a doubling of attendances within the country in just 5 years. In light of these challenges, BASHH continues to collaborate with a range of national representative bodies, professional and third sector organisations to raise the importance of maintaining high-quality, easily accessible sexual health services across the UK. Ensuring this is especially important in a time which has seen the emergence of multi-drug resistant gonorrhoea and a significant rise in numbers of cases of syphilis.

To draw attention to these issues, in January 2018, BASHH launched an online *'Save our Sexual Health Services'* public petition, supported by 25 leading patient, professional and third sector organisations. The petition was promoted by a proactive social media campaign and was signed by 7,000 individuals over a 6-month period. BASHH has also produced key metrics *'the Hot Six'* to help services more accurately identify their pressure points and aid pan-UK benchmarking. Evidence gathered provides valuable information in support of the ongoing campaign to improve funding of services.

The volume of issues on the horizon is reflected in the number of key consultations that we have responded to in recent months. These have included a review of Public Health Prescribed Activity, The National Health Service (Charges to Overseas Visitors)(Amendment) Regulations 2017, detailed input into the new NICE Quality Standard on Sexual Health and joint engagement with other stakeholders regarding the proposed Assaults on Emergency Workers (Offences) Bill 2017-19.

Through partnership working we have secured a programme to deliver the quadrivalent human papilloma virus (HPV) vaccine for boys and a national vaccination programme for men who have sex with men (MSM) across the UK. Pre-exposure prophylaxis (PrEP) is provided for high risk individuals in Scotland, Wales and Northern Ireland on the NHS but only accessible via PrEP Impact clinical trial in England. BASHH have called for PrEP to be available in England by April 2019 prior to the trial being concluded.

Production of guidelines and standards are an essential aspect of our remit. Our Clinical Effectiveness Unit has been extremely busy and has co-produced with BHIVA guidelines on the use of HIV pre-exposure prophylaxis, and with both BHIVA and FSRH, guidelines for the sexual and reproductive health of people living with HIV. Guidelines for Pelvic Infection and Donovanosis were updated and new NICE accredited guidelines for Mycoplasma Genitalium were published.

Our educational activities go from strength to strength, providing high quality content which receives excellent feedback on a variety of platforms. The activities continue to provide our Members and the wider community of health professionals with excellent educational events across the UK throughout the year. The joint BHIVA /BASHH conference in Edinburgh attracted over 1,000 delegates and our annual joint meeting with FSRH was fully subscribed.

The media team have had an exceptionally busy year, responding to a record number of enquiries and appearing on almost all leading TV, radio and online outlets in the process. Close collaboration with the BHIVA media team has enabled both Associations to gain a wider reach and raise the profile of contemporaneous issues in the field of sexual health and HIV. The launch of the M. Gen guidelines provided a particular highlight, with wall-to-wall coverage which included the New York Post, ABC News Australia and the International Business Times. All of this has contributed to the continued growth of our Twitter presence @BASHH\_UK, which has increased its followers to over 6,000.

Our Centenary Year in which we recognised the tremendous progress made since the introduction of the Venereal Diseases Act concluded with a celebratory dinner at The Apothecaries and a fun and unique Venereology Concert Party.

Despite the challenges we're faced with, BASHH continues to be a successful and vibrant organisation, proudly promoting excellence in sexual health and HIV care, delivering high quality education, seeking to influence national decision makers for the improvement of public health and also most importantly working for the benefit of the public. We acknowledge and thank all of the Members, Officers and Trustees for their time, commitment and enthusiasm, without which none of the above would be possible.

## Treasurer's report

BASHH had a stable financial year. The joint meeting with BHIVA and dividends and investment gains from our investment portfolio contributed to overall robust and positive financial results with a net surplus for the year of £19,557. The value of the investments has continued to rise and has contributed significantly to BASHH's reserves. However due to the financial commitments to pay in advance for the venues for the BASHH annual spring conferences until 2021 (deposits in excess of £100,000 have been paid as at 31 July 2018) BASHH's cash reserves dropped from £466,142 at the end of the previous financial year to £306,459 at the end of this financial year. These deposits will be utilised subsequent to holding the spring conferences in future years and the revenues from these conferences should have a positive effect on the cash balances. Although the association's financial state remains robust, it is important to note that without the investment income and the growth in investment assets the association's costs currently and during the last couple of years outweigh its income from its normal charitable activities. Subsequent to the year end the world stock markets have been in decline and it is likely that the results next year show negative returns from our investments. As we expect a turbulent few years post Brexit for the stock market, it would be important to note that our finances may come under strain in the coming years. The main drivers of our expenses are our educational meetings and secretariat fees. They each have increased by 15% in 2018. Our contract with KSAM is to be renewed in January 2019. The current proposal is a 12% increase in our secretariat fees and this would impact also on our future finances. Detailed results of our activities during the year are given within these audited financial statements.

### Principle funding sources

Income for the charity comes from investments, membership subscriptions, and educational events. Because of the charity's stable financial position, the annual membership fee was not increased in 2018. The joint BASHH/ BHIVA conference was financially successful. The surplus generated was smaller than the meeting held during 2014. BASHH may have to plan its resources around a lower expectation of income from the meetings in future years. Results from the other main educational events managed and delivered by the association's special interest groups are given within the financial statements.

## Clinical Governance Committee Review

In addition, there are Professional Group Representatives from Nurses, Health Advisers, Staff & Associate Specialists, and Doctors in Training.

Other groups within BASHH feed into this committee, the Clinical Effectiveness Group, the Clinical Standards Unit, the National Audit Group, the Integrated Information Group and the Web Team.

### Objectives

- Implement strategies and policies of BASHH as approved by the Governing Board
- Set and monitor standards and specifications
- Identify areas of best clinical practice and promote them for adoption where appropriate whilst recognizing local differences
- Identify regional and individual clinic difficulties
- Explore solutions to issues and suggest action plans

### Meetings

The Committee holds meetings on the same days as the Scientific Meetings. In the Year ended 31st July 2018, 3 face to face meetings were held, a fourth meeting was held as a teleconference utilising Adobe Connect for document review in June 2018, as the IUSTI meeting was the Scientific Meeting supported by BASHH that quarter.

### Significant activities

- Spotlight discussions were held on topics maintaining quality within new contracts for services and addressing issues arising from contract changeovers and retendering; maintaining standards for online STI screening services and integration with face to face services; the rollout of the PrEP IMPACT Trial and PrEP services, and service issues arising across the UK including ways to improve the interactions of branches with local BASHH members.
- The CGC contributed to BASHH Survey of impact of service changes in 2017/18 and commenced work on developing a BASHH recognised acronym glossary to support local service usage within local guidelines
- The Royal College of Physicians provided a pathway for action when Regional Advisers for Service were unavailable for input into consultant appointments and this was formally agreed and adopted by the Committee.
- Regional Advisers and Consultants continue to contribute to this work
- The CGC contribute to the generation of and content of papers created by BASHH Officers for external partner organisations affecting sexual health policy

### **Performance/Outputs in the year 2017/18**

- The functions and geographical coverage of branches in relation to effectiveness of meetings, clinical networks, safety and intelligence reporting, and effective representation of local members was reviewed and discussed formally. No changes of boundaries or formal mergers have taken place but regions were encouraged to consider and support joint meetings between co-terminous branches.
- Advice on Ceftriaxone usage, spectinomycin usage was discussed and strategies circulated to support services in context of occasional stock shortage and in management of suspected penicillin allergy in different clinical settings.
- Communication and dissemination of information relating to Hepatitis A outbreak, and management of supply chain issues with Hepatitis A, Hepatitis B and Twinrix vaccination stock across the regions, was co-ordinated and support.
- Accurate minutes of meetings were kept and published

### **Future plans**

- To facilitate CGC members fulfilling branch, group and national roles by providing travel expenses if not employer-funded, and increasing the use of teleconferencing.
- To develop a BASHH resource of common acronyms and glossary to support a diverse range of services maintaining local guidelines
- To support BASHH commitment to equitable geographical provision of safe, effective and accessible on-line services that support high standard face to face sexual health services

## **Education committee review**

The Education Committee is responsible for facilitating the delivery of the BASHH's vision, values and service priorities through education, training and development. This is particularly important in the current challenging healthcare environment where resources are stretched and value for money must be demonstrated in all educational products. The Educational committee (EC) and Special Interest Groups (SIGs) have developed and maintained educational programmes providing high levels of specialist training and skill, whilst embracing a wider, more integrated sexual health remit across a wide geographical area and range of healthcare settings.

### ***The Special interest groups (SIGs)***

The SIGs are responsible for leading on development of educational materials, meetings and training needs analysis within their specialist areas. They develop and deliver educational programmes and courses. They also contribute to education and training by generating publications and research, developing guidelines and recommendations in collaboration with other BASHH groups and external organisations, and reviewing and responding to documents on behalf of BASHH. Individual reports detailing specific contributions are available in the BASHH Annual Review. This year, the SIGs have provided several well-established courses such as the BASHH microscopy course, SAS and Doctors in training meetings, the genital dermatology course, surgical techniques in GUM course, ABC of sexual dysfunction course, the Diplomas in GUM and HIV revision courses, STI Foundation theory and competency courses and the HIV Masterclass. There have also been new courses developed including two joint HIV nurse training packages with the national HIV Nurses association (NHIVNA). These are called 'STIF-NHIVNA core competency' training and 'STIF NHIVNA advanced competency' training. Some BASHH educational products have also been delivered

internationally, including a STI Foundation course delivered in Lusaka, Zambia in July 2017.

In early 2018 new BASHH group specifically representing Nurses and Health Advisors has been established which now also contributes to the EC.

### ***BASHH scientific meetings***

The EC has the responsibility of providing 4 scientific meetings annually, which are free to delegates, including invited lectures from BASHH Honorary Life Members and Professorial lecturers. SIGs take it in turn to organise these meetings and they often take a two-part structure, organised by two individual SIGs. This year, the October meeting was lead by the Adolescent SIG (CSE theme) and Education committee (Medical Education theme). The January meeting was lead by the GSM (WSW theme) and HIV SIGs (Issues specific to women living with HIV). The March meeting was organised by the Bacterial SIG and Public Health England and the September meeting was organised by the HSV SIG and GSM SIG. These were all well attended with excellent evaluation. Availability of podcasts/webcasts of the lectures has been reinstated since January and continues to facilitate access for those BASHH members who are unable to attend in person. Programmes are available on the BASHH website.

### ***Other meetings***

Fourth Joint Conference of BASHH with the British HIV Association (BHIVA) took place in Edinburgh in April 2018. It was again very highly evaluated and proved to be an excellent educational event. The annual Joint BASHH /FSRH meeting in January also continues to be well attended and very successful. The Conference and Communications secretary's report will provide more detailed feedback.

### ***Further EC plans***

The EC has established a new Fellowship for Doctors in Training called the BASHH Educational Fellowship. Three applications of high calibre were received this year and the successful candidate, Dr Laura Gillespie (Sandyford Sexual health Service, Glasgow), has commenced a 12-month educational project with the STIF Competency group. The EC plans to award one fellowship per year going forward, if suitably qualified candidates apply.

Next year's BASHH spring meeting will be held in Birmingham and preparations are well underway. The BASHH Board has agreed to cancel the Sept 2019 Scientific meeting and instead support the attendance of junior BASHH members at the IUSTI conference in Tallinn next year. The ASIG will be running a BASHH Symposium on sexual exploitation at this meeting. Plans are underway to try and establish an international educational fund to help support and promote BASHH's educational projects being delivered overseas.

### Objectives

- To recommend strategies for IT implementation, data collection and reporting for the spectrum of Sexual Health services (ranging from non-integrated services to fully integrated services).
- To advise on the type, quality and format of information to be collected from Sexual Health services for the purposes of national audit, public health monitoring and monitoring of service performance.
- To respond to relevant consultations affecting service provision and data collection in Sexual Health.
- To liaise between DH, HSCIC, PHE and other agencies regarding information issues to achieve best outcomes for both patient and public health.
- To receive and respond to queries and concerns from members relating to IT and Information Governance, including data protection and confidentiality rules.
- To anticipate issues relating to IT and Information Governance from new legislation, commissioning or other changes that affect Sexual Health.
- To disseminate important information to BASHH/Faculty members via organisational websites/newsletters.

### Significant activities

- The Group met on 3 occasions during 2017/18.
- We have considered matters of relevance to GUM Clinics, SRH clinics and Integrated Services in particular in relation to statutory reporting through SRHAD and SHHAPT coding.

- We have deliberated the implications of GDPR for sexual health services and advised BASHH accordingly, including and a coordinated response with PHE re-asserting the legal basis for data-sharing to fulfil statutory obligations.
- We have advised PHE on matters arising including: Data compatibility and mapping of SHHAPT to SNOMED, review of coding for bacterial infections, development of HARS and deployment of GUMCADv3.
- We have responded on behalf of BASHH to the NHS Digital Consultation on the legally un-sharable dataset in relation to the future of data sharing between agencies.
- We have represented BASHH at the RCP project for standardising encoding of diagnostic categories Medical Specialties.
- We have contributed authorship of the Standards for Online Sexual Health Services.
- We have reviewed and updated sections of the e-Learning for Health relating to information governance.

### Future plans

- To continue to work closely with members of the Faculty, PHE, DH, NHS Digital, software providers and others to ensure that we meet our objectives.
- To ensure the objectives and benefits of this group incorporate relevant issues for all devolved nations of the UK.
- To be both pro-active and responsive to upcoming matters that affect data handling and Information Governance to find the best solutions.
- To perform a review of the functionality of Sexual Health software systems in order to promote innovations from providers that will improve the ease and quality of clinical coding for clinical services.
- To encourage and facilitate NHS Digital and PHE collaborate work to work towards a unified coding system for Sexual Health.

## Media Group

The Media Group has responded swiftly to a multitude of media requests throughout the year, including those from online media, newsprint, radio and television. BASHH provided expert opinion on recent increased rates of sexually transmitted infections, particularly gonorrhoea and syphilis, and including the first case of gonorrhoea which is resistant to all standard antibiotics. The recent public health funding cuts prompted a strong media response. Clinic closures, particularly following the London Transformation Project, attracted much attention and BASHH has highlighted the need to maintain high quality clinical sexual health services measured against nationally agreed standards, which are resourced appropriately. BASHH also supported the roll out of the Human Papillomavirus vaccine to men who have sex with men, and the planned inclusion of all boys of school age, reducing the previous inequality in vaccine provision.

## Objectives

### Significant activities

- 2018 national audit of HIV partner notification (PN): a site survey was completed by 149 services and case-note review data were received for 2753 adult index cases diagnosed with HIV during 2016-7. Nationally the standard for contacts tested per index case was met, with improvement since the 2013 joint BASHH/BHIVA audit (0.86 verified by health care worker, 0.99 verified or reported by index case, compared with standards of 0.6 and 0.8). Standards for the proportion of contactable contacts tested, the proportion of index cases with a PN plan within 4 weeks, and the proportion of index cases with documented immediate PN regarding possible eligibility for PEP were not met. Services are recommended to continue to pursue PN as an effective way of diagnosing HIV. BASHH/BHIVA/SHHA/NAT are recommended to revise and update standards to clarify definitions further.
- Follow-up of 2017 syphilis audit: 43 clinics responded to a follow-up survey and about 40% of these reported reductions in the number of health advisors or their diversion to non-PN work
- Review of auditable outcomes in draft CEG guidelines on gonorrhoea, candida, M. genitalium
- Production of a standard template to guide authors of articles based on BASHH audits for peer-reviewed publication

## Public Panel

The BASHH public panel is a group of lay, professional and third sector members, which aims to involve patients and the public in the work of BASHH. In addition, a lay research panel, which reports to the main panel and is run collaboratively with the Terrence Higgins Trust (THT), provides lay input into sexual health orientated research proposals and projects. There are approximately 30 members across both panels.

One of the core activities of the public panel is the review and co-production of STI treatment guidelines and patient information leaflets associated with those guidelines. This year, the panel has run an event, in collaboration with Brook young people, to ensure a new young person's STI management guideline had strong patient involvement. The panel has also contributed strongly to new guidance on *Mycoplasma Genitalium* and gonorrhoea by supporting lay membership of these guideline writing groups. Another key collaboration this year has been with the Family Planning Association (FPA) with panel members providing editorial input to a new series of animated patient information films (sexwise). Finally, panel members are part of the review team for the NHS 'Health Unlocked' resource, where the public can ask questions and find answers to their sexual health queries.

The lay research panel performed three project reviews this year and, under new leadership, is poised to expand and develop into a valuable resource for STI researchers, funded by BASHH and supported by THT. Lay members are given training and are remunerated for their travel and the time they spend on project reviews.

Beyond these core activities, the panel organised a successful concert party in November 2017, open to the public, which celebrated the centenary of the Venereal Diseases Act through song!

### Objectives:

## STI & HIV Course

### Objectives

- The BASHH STI & HIV Course consists of 4 modules that run once a year covering:
  - **Module 1:** Epidemiology of STIs and Bacterial Infections
  - **Module 2:** Sexual health and sexuality
  - **Module 3:** Viral Infections other than HIV
  - **Module 4:** HIV infections
- It aims to improve knowledge and management of STIs and HIV to current national standards and to aid those sitting the Diploma in GUM and Diploma in HIV exams. Within the last year, the HIV Module has been opened out to include a wider specialist audience including HIV Clinical Nurse Specialists and Specialist Pharmacists who are non-medical prescribers and have their own cohort of patients.

### Significant activities

- **Education Grant.** An increased Education grant of £14,400 was awarded in 2017 to allow funded places for the HIV Module, specifically for other specialists in the MDT e.g. Clinical Nurse Specialists and Specialist Pharmacists with their own patient cohorts. This approach was piloted in 2016 with excellent feedback and an increased education grant was therefore requested for 2017.
- **Feedback.** Despite the decreasing number of registrars, the course has continued to run successfully. Evaluation of the feedback and module programmes has continued throughout this reporting year. Feedback has continued to be excellent.
- **Course Programme.** The course programme and course length has been evaluated. The feedback from specialist registrars was to keep the course the same length; however this will be reviewed again in 2018. New elements to the course have been included following the updated GUM curriculum (for example, psychosexual session organised in liaison with the Sexual Dysfunction SIG)
- **Mapping to DIPGUM examination.** Liaison has now taken place with the DIPGUM leads (Best of 5 Lead and OSCE lead) to ensure alignment with the DIPGUM examinations.
- **E-learning.** Liaison with e-lfh Lead for STI-HIV modules has been completed. The HIV Module has been mapped to the e-lfh e-learning modules. E-learning for this module prior to course attendance is being piloted in the nurse specialist and specialist pharmacists cohort. The aim is to extend the e-learning module mapping to cover the rest of the course and give this information to delegates prior to course attendance
- **Online course material.** This has been approved to allow course material to be transferred onto the BASHH website. This will allow secure access to course delegates.

### Performance/Outputs

- Numbers of attendees for the four modules of the course:
  - Module 1: 19
  - Module 2: 17
  - Module 3: 21
  - Module 4: 49

## Future plans

- Full mapping of e-learning (e-lfh) STI-HIV modules to course content and to the GUM Curriculum with a plan to request delegates to complete e-learning prior to course attendance.

### Objectives

The Joint Specialty Committee (JSC) for Genitourinary Medicine (GUM) acts as an advisory body to the Royal College of Physicians (RCP) on matters concerning sexual health and HIV. It meets twice a year and has a membership drawn from both the RCP and BASHH, including representation from the RCP Patient and Carer Network.

### Performance/Outputs in the year 2017/2018

- The Committee met as planned in November 2017 and May 2018 and has ensured that the RCP is fully advised about the issues affecting the specialty, such as workforce planning and training, hepatitis A and B vaccine supply issues, roll-out of human papilloma virus vaccine to men who have sex with men, the HIV Pre-Exposure Prophylaxis (PrEP) Impact Trial, and commissioning and tendering of HIV and sexual health services.
- BASHH and the RCP have contributed to successful efforts to stop the inappropriate sharing of identifiable NHS patient information of migrants and thus halt unintended health consequences.
- A second round of recommendations for the Academy of Medical Royal Colleges 'Choosing Wisely' initiative was undertaken during the year, with contributions from the Committee.
- The Committee has also responded to numerous national consultations.

### Future Plans

The Committee will continue ensure that issues of importance to the speciality are raised with the RCP, will make constructive contributions to the Health and Social Care Committee's inquiry into sexual health and will provide input to the RCP London 500 year celebrations.

### Curriculum:

Rewriting of GUM curriculum, in line with the new physician training model to meet the GMC's revised standards for curriculum and assessment, continues. The first dually accredited GUM physicians will complete training in 2026. Transition arrangements for existing trainees in programme from 2022 continue to be discussed. The GUM SAC held a curriculum writing meeting after the SAC on 15 June 2018, with input from all GUM TPDs and have represented GUM at the RCP curriculum writing day on 19 December 2017. A second RCP curriculum day is planned on 5 December 2018 to include presentations on how best to meet standards of equality and diversity within curricula.

All specialties will now have to go through a two stage process for their curriculum approval. For stage one, they will now need to gain Strategic Support for their new curriculum from the GMC Curriculum Oversight Group (COG), which is made up of representatives from the four nations; the SAC has written a purpose statement to provide a rationale for its curriculum, which was submitted in August 2018. The COG fed back that it supported the specialty specific outcomes described in the purpose statement, noting the commitments to community care and the broad generalist nature of the proposals as positive aspects. However, they were unable to make an approval decision to any of the September submissions, pending further discussions with JRCPTB around the wider model and the structure of the higher specialty physician training programme as a whole. An outcome is expected by the end of 2018.

Stage two will be the Curriculum Development and approval process. Curriculum approval involves an electronic submission via the secure GMC Connect portal, which will be reviewed for approval by the Curriculum Advisory Group.

### **GUM recruitment**

Specialty recruitment in 2018 has again proved challenging. There was a notable reduction in applicant numbers this year, with just 22 applicants for 37 posts in Round 1, representing a 40% reduction since 2017. Of these applicants, 16 received offers and 13 (81%) accepted these offers, resulting in an overall fill rate of 35%. This is the lowest overall fill rate to date for the specialty for R1, with 24 included NTN's remaining unfilled across England, Scotland and Wales and 7 fewer posts filled compared with 2017. This is the second lowest fill rate of the 24 medical specialties with recruitment co-ordinated by the JRCPTB. The high rate of unique applications (59%) reflects the on-going interest for the specialty amongst those who did apply – only 3 of the 13 Shape of Training Group 1 "unscheduled care" specialties (within which GUM sits) had higher numbers of unique applicants. Similarly, the specialty continues to attract some high-scoring excellent trainees amongst the successful candidates.

Geographically there was a notable decrease in fill rates of the London/KSS vacancies since 2017 (a 49% decrease) compared to a drop of 34% elsewhere. Two LETBs filled all available vacancies and 5 LETBs failed to fill any included post, which includes Scotland and Wales.

For the second round of recruitment there were 21 posts available and just one applicant, who was not a unique applicant. Following discussions between the SAC chairs, the recruitment leads and the recruitment office it was decided that the round should be cancelled, given the associated draw on resources (both interviewer time and financial) associated with running a selection centre, and opportunities for locum work in the specialty for the candidate until the next recruitment round.

The effects of the commissioning changes and resultant trainee career uncertainty on recruitment to GUM have been raised with HEE via the Sexual Health, Reproductive Health and HIV workforce project. Despite these challenges, career opportunities in GUM are good. In 2017, the number of advertised consultant posts exceeded the number of trainees achieving CCT; however this is not widely recognised by other agencies. Avenues for dispelling possible misunderstandings regarding future career opportunities, promoting on-going awareness of the specialty amongst junior doctors, and making training in the specialty more appealing continue to be explored. The possible impact of Shape of Training proposals on GUM recruitment is unclear and remains to be seen.

### **Dip GUM/Dip HIV:**

These diplomas will move to a single diet from 2020 with Dip GUM scheduled to be sat over two consecutive days in December and Dip HIV over two consecutive days in June. For a trainee failing both exams once, the shortest duration between exams would be six months between the Dip GUM re-sit and the Dip HIV. ARCP decision aids will be amended to reflect that Dip GUM can be passed by end of ST5. TPDs will exert local flexibility at ARCP over the time frame for passing these exams in the light of the reduced frequency of diets. Both convenors are currently submitting documents to the GMC to approve the change.

### **Workforce planning**

The co-chairs of the SAC, on behalf of BASHH, attended 5 meetings of the Sexual Health & HIV workforce action planning task & finish group between July 2017 and March 2018, chaired by Professor Selena Gray, Deputy Dean of SW HEE and Lead Dean for cSRH. The 'Improving the delivery of sexual health services: Sexual health, reproductive health and HIV workforce scoping project report' was published in September 2018, by Health Education England, and has been submitted as evidence to Health and Social Care Committee inquiry into sexual health. The following recommendations were made to BASHH & the GUM SAC:

- HEE would support the development of the Advanced Clinical Practitioner (ACP) role in integrated sexual health

The GUM SAC and their specialty workforce leads should:

- Monitor the impact on recruitment in genitourinary medicine and sexual and reproductive healthcare of commissioning decisions by local authorities.
- Map independent training centres to establish the capacity for training in the independent and third sector in this field, e.g. General Medical Council accreditation.
- Review the impact on recruitment and retention of GUM specialty trainees as a result of the introduction of dual GIM/GUM accreditation.
- Consider models for the development and maintenance of specialist HIV inpatient skills in the context of reducing inpatient episodes and consolidation of inpatient services.
- Develop methods to gain and maintain skills in managing HIV as a long-term condition as those currently affected age and the prevalence of multiple co-morbidities increases.
- BASHH should:
- Review consultant and nursing staff to patient ratio standards in light of changes to service delivery models in sexual health and reproductive health services.
- Work with the Royal College of General Practitioners and Royal College of Nurses to develop a structured curriculum and skills passport that would support a career pathway for nurses and allied health professionals working in sexual health, reproductive health and HIV, including pathways for those working in primary care, sexual and reproductive health services, abortion care and sexual assault services and associated leadership roles.
- Explore the development of an e-learning module for healthcare professionals acknowledging the increasing role of peer support and how to use it in the delivery of HIV care.

### **Other significant activities**

The SAC co-chair, Margaret Kingston, gave evidence at an All Party Parliamentary Group on the hugely detrimental impact that the Health & Social Care Act (2012) and subsequent cuts to public health funding have had on sexual health services. She specifically spoke about how these had created such career instability and poor morale that in many areas we are struggling to recruit and retain medical staff. She has also submitted evidence to this effect to the Sexual Health Inquiry; Health & Social Care Committee and is attending a parliamentary briefing for MPs at the House of Commons.

The National GUM taster day, organised by the South London STC, took place at the London Deanery on 23 October 2018. There were 60 attendees of whom the majority were in their FY1, FY2 or CM1 years.

## **UEMS in Dermatovenereology**

### **Objectives**

The future relationship of UK with UEMS post Brexit has been subject of much debate at specialty, BMA and GMC. My aim has been to ensure we enable good communications and collaboration with colleagues in UEMS with regard to training, standards and development of our specialty.

### **Significant activities**

The relationship between venereology and dermatology as well as other specialties such as infectious diseases, urology, andrology and gynaecology has been subject of much interest and debate as the evolution of clinical services evolves in different ways across EU.

### **Future plans**

I will demit my role in 2019 after serving two 4 year terms on UEMS and will handover to a successor at a cathartic time in European politics. I believe absolutely critical we as BASHH continue to influence our specialty across Europe.

## Journals with BASHH representation

### International Journal of Sexually transmitted diseases & AIDS

IJSA has continued to expand its published volume in the last year and has increased its Impact Factor. The journal publishes more research papers than any other journal in the STI field and continues to be the major publication for BASHH/European guidelines, BASHH papers as well as case reports and audits from BASHH members. IJSA continues to accept a wide range of papers from all corners of the globe that we hope provide readers with a variety of interesting and clinically useful material. As Editor, I am very grateful to all contributing authors and our esteemed reviewers, as well as to SAGE Publishing for making another successful year possible.

### Sexually Transmitted Infections Journal

*Sexually Transmitted Infections* journal continues to develop as a global journal with distinctive content for its BASHH subscribers. In 2016 there were over 670 submissions, and in the first half of 2017 there were 208 submissions of which 59% were original articles). We now publish online within days of acceptance, and our content is promoted globally and worldwide through our active Twitter and Facebook accounts. Highly accessed articles include a mystery shopper report on access to GU clinics in the UK, an interesting controversy on the relationship between syphilis transmission and HIV antiviral therapies, and many articles from our October 2016 special issue on STI outbreaks. While we enjoy our place at the top of global STI journals impact factors, we continue to prioritise building our clinical and educational content for BASHH members through a dedicated team of UK based clinicians. Sarah Edwards edits and commissions Educational (How To Do It) articles, sometimes adapting research submissions to provide practical lessons and discussions for colleagues. Sophie Herbert has been joined by Emily Chung as authors of our regular "Clinical Roundup" which brings the best of other journals together for our readers. I am constantly grateful for the commitment and dedication of my editorial team, who support our authors to bring their work to the highest standards for publication.

Some of you may have been aware that the post of Editor in Chief was advertised in 2016. BMJ Group publishing was not able at that time to appoint a team able to serve our diverse international and UK based subscribers, from clinicians to policymakers. We made a few changes to our team of editors, some of whom had served for many years, to bring in new blood for the period to the end of 2018. As Editor in Chief I have very much enjoyed staying on to serve the journal in the Centenary Year of the UK's world leading Venereal Disease Regulations which opened the way for the supportive, confidential services. Next year, I will be however standing down in order to meet other obligations. I very much hope that BASHH members with editorial experience will consider applying for this role, alone or with a complementary team. Editing a professional journal is a unique opportunity to serve the wider interests and ambitions of colleagues, and to support colleagues through times of change and uncertainty.

I would like to thank the many BASHH authors who have submitted to the journal, advised on educational material, or acted as reviewers to ensure the relevance of our content to UK readers. I am also grateful for hard work and support from our Deputy Editors (Nicola Low and Gwenda Hughes), and a wider team of Associate Editors who support our authors through peer review and tireless promotion of the research and commentary we publish.
